BACKGROUND AND PURPOSE

The Swedish construction industry is experiencing the biggest expansion in decades, with big-scale investments planned in both infrastructure and real estate. This rapid increase in demand for construction firms has created lucrative opportunities for foreign actors looking to enter Scandinavia’s biggest construction market.

One of the greatest challenges for international companies has proven to be understanding and navigating the Swedish regulations for construction work. The regulations are strictly enforced by the authorities and understanding them is paramount to winning and profiting from construction contracts in Sweden.

To assist international contractors, two different short introduction courses, Infrastructure and Real estate, have been developed to cover the fundamental aspects of the Swedish construction industry.

COURSE DESCRIPTION

COURSE OBJECTIVE

The objective of the courses is to give an introduction to statutes and regulations that are unique to the Swedish construction industry. The intention is to supplement the contractors’ practical expertise with knowledge of the Swedish regulatory framework, focusing on aspects that have a direct impact on project profitability.

COURSE CONTENT

The courses are available in two different versions focused on real estate and infrastructure, respectively. The curriculum covers the essential legal and procedural aspects of bidding for and executing construction contracts in Sweden. Topics include procurement legislation, bidding and payment formalities and requirements to pass on-site inspections. The lecturers highlight important parts of the regulatory texts, as well as unwritten rules and standard practices. Please see the curriculum for each course on the following pages.

WHO SHOULD ATTEND?

The courses are targeted at experienced, foreign contractors who are looking to supplement their practical experience with knowledge of Swedish procedures and regulations. The market

The Swedish government, through The National Board of Housing, Building and Planning, has estimated that there is a need to construct 710 000 dwellings in Sweden until 2025.

This need implies that the industry would have to construct 88 000 dwellings per year until 2025. With the current pace in mind, it will not be possible for the industry to fulfill this need.

The picture looks similar for the infrastructure sector as large projects are planned and there is a lack of capacity to construct both infrastructure and construction projects.

The Swedish market is complex and there are different barriers to enter the market. In order to clear the barriers, clarify the conditions and help you succeed, we are glad to offer you two different introduction courses of which you can read more in this brochure.
